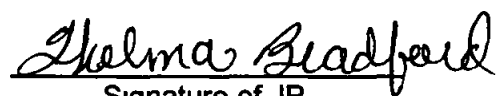

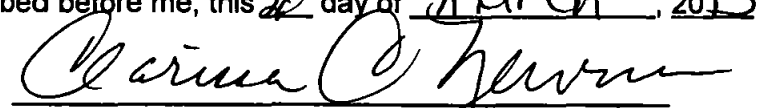
AFFIDAVIT
